Size

5" wide x 7" high

The 5x7 ads are purchased by the number of locations. Your ad will be placed in every building in the target market that you have purchased. Minimum contract period is 6 months with an additional 5% discount for a 1 year contract. The following rates are "per month".

Art Set Up and Production, Deadlines for Ads

Services available includes, Design, Layout and and Set Up. Cost is \$150.00 plus \$2.00 per print (duplicate set required for rotation). All artwork must be supplied by the 20th of each month.

Contract Period and Deposit

Contracts are 6 month minimum terms. A one month deposit is required to secure placement, which is applicable to the last month of service upon signing of advertising agreement.

Discount

10% discount on 12 month contracts.

Cancellation

Advertiser may only cancel a contractual agreement on 60 days written notice. In the event of such a cancellation, an advertiser who has been granted a discount, agrees to pay an adjustment to the rate applicable to the number of insertions used.

Sizes

2" wide x 3.75" high, or 4" wide x 2" high

Location

In the center of an elevator advertising board, with 5x7 ads located on the left and right.

The biz card ads are purchased on a per area basis. Your ad will be placed in every building in the target market that you have purchased. Minimum contract period is 6 months with an additional 10% discount for a 1 year contract. The following rates are "per month".

Superboard Landscape - 9" wide x 6.75" high

The SuperBoard ads are purchased by the number of locations and are available only in multiple elevator buildings in Vancouver. Minimum contract period is 10 buildings per month for 6 months.

The following rates are "per building per month"

For example, if you purchase a Super Board Poster Ad (9"x14") in 12 buildings, the monthly fee would be 12 x \$52.00 each = \$624.00 per month. discount for a 1 year contract.

Payment and art no later than 10 days prior to posting. Ad campaigns payable in advance and in full. Monthly payments available only by Pre-Authorized payment. Last month deposit, art set up and void cheque with agreement.

Contract Period
